ALLEGANY COUNTY LANDBANK-JASON ISAMAN-

Jason Isaman gave a brief presentation on the Allegany County Landbank (whom are a nonprofit agency) and their intentions for 4-6 West Main St. They will be working along with Ashley Smith and the Main Street Committee. They take properties that are run down and revitalize them. They now have a contract to buy 4-6 W. Main Street, which are 2 of the oldest buildings in Friendship. It is eligible for the Historical Registry, and they would not be able to pursue this if they did not get a historical tax credit. There will be a 50% tax credit for interested buyers. There was an Engineer hired and there is a plan to move forward to stop the deterioration of the building they are looking for longer term development, a lot of upgrades need to be done. They plan to eventually have store front leasers on the bottom and apartments on the top floor. Looking into the possibilities of obtaining 8 West Main,

which is right next door, this will be going up for taxes. Will have to be torn down due to it falling in.

The Land bank will invest in funds for this project, but they are looking for the Town to also invest.

They made an offer on the Antique Barn to the owner because he wants to get rid of it and The Land Bank is 2 looking for parking options. He needs a Resolution from the Town Supporting the Land Bank project, Main Street Revitalization.

After further discussion the following Resolution was set forth.

RESOLUTION 10-2025 Order Calling Public Hearing

WHEREAS, the Town Board of the Town of Friendship, Allegany County, New York, has caused to be prepared a map, plan and report, including an estimate of cost, as supplemented, pursuant to Section 202-b of the Town Law, relating to the increase and improvements to the facilities of the Friendship Sewer District ("Sewer District"), in the Town of Friendship, Allegany County, New York, consisting of the replacement of the existing comminutor with the new headworks, construction/rehabilitation of the biological treatment process, new/rehab of the effluent disinfection system, and improvements to the sludge handling/disposal system together with collection system improvements including CIP pipe lining, sewer main replacement and manhole rehabilitation and original furnishings, equipment, machinery, apparatus, appurtenances and incidental improvements and expenses in connection therewith, at a maximum estimated cost of \$8,200,000; and

WHEREAS, it has now been determined that the maximum estimated cost to said Sewer District is \$10,834,916, an increase of \$2,634,916 over that previously estimated; and

WHEREAS, the capital project hereinafter described, as proposed, has been determined to be a Type I Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, which, it has been determined will not have any significant adverse impact on the environment; and

WHEREAS, it is now desired to call a public hearing on the question of the increase and improvement of the facilities of said Sewer District, in the matter described above, and to hear all persons interested in the subject thereof, concerning the same, in accordance with the provisions of Section 202-b of the Town Law; NOW, THEREFORE, IT IS HEREBY

ORDERED, by the Town Board of the Town of Friendship, Allegany County, New York, as follows:

Section 1. A public hearing will be held in the Town Hall, in Friendship, New York, in said Town, on July 16, 2025, at 6:00 o'clock P.M., Prevailing Time, on the question of the increase and improvement of the facilities of The Town of Friendship Sewer District, in the Town of Friendship, Allegany County, New York, at the revised maximum estimated cost, in the manner described in the preambles hereof, and to hear all persons interested in the subject

thereof, concerning the same, and to take such action thereon as is required or authorized by law.

Section 2. The Town Clerk is hereby authorized and directed to cause a copy of the Notice of Public Hearing hereinafter provided to be published once in the official newspaper, and also to cause a copy thereof to be posted on the sign board of the Town, such publication and posting to be made not less than ten, nor more than twenty, days before the date designated for the hearing.

Section 3. The notice of public hearing shall be in substantially the form attached hereto as Exhibit A and hereby made a part hereof.

<u>Section 4</u>. This Order shall take effect immediately.
