A public hearing was held before the Town Board at 6:45P.M. to hear all persons interested in the matter of the adoption of the Introductory Local Law No. 1 of 2025 entitled "A Local Law to Override the Real Property Tax Cap Levy Established by General Municipal Law Section 3-c@ for the purpose of enabling the Town Board to adopt a budget for 2026 that exceeds the 2025 real property tax levy by more than 2.0%.

The Tax Cap Override Local Law is only necessary if there are insufficient resources available to the Town of Friendship to meet the budget for 2026. The Board members answered questions from those present for the public hearing. The Supervisor declared the public hearing to be closed. It was discussed by the Supervisor that the Town was not over the 2% tax cap.

Following the closure of the public hearing the Town Board considered the adoption of the proposed local law for which the public hearing had earlier been held.

4-6 Depot Fire Debris-

4-6 Depot Street Code Enforcement time limit for cleanup - Certified Letter was sent from the Code Enforcement and he has been given date to respond with no response. Owner Unable to comply. He has been approached that there were interested parties that made offers, he either refused or just would not have a conversation. The Utility Companies are now holding the Town responsible d/t Utilities. Board will have to approve the expenditure and figure out from where \$20,000.00 to 64,000.00 will come from if they were to clean it up. The Town does not have the funds to clean it up, they would have to borrow the money. How about putting a judgement against the now owner? Attorney Buck was asked if he could look into whether the Town could relevy the cost of the cleanup or what steps the Town would take next to achieve the property to be able to clean it up.

Attorney Buck will look into this and get back with the Supervisor.

Public Concerns:

Jake Blouvet wanted to know if anything was talked about or resolved with the Refuse from last meeting. Dave Norton advised they had some conversation but needed to include Oakley Sortore and need his input but did not want to pull him from the water and sewer. Mr. Blouvet wanted to know who is on the committee, he was advised the 2 board members on were Dave Norton and Linda Mascho. Supervisor Hall advised it is no more than 2 Board members because if more than 2 board members get together then it is a quorum, more than two you have to call a meeting. Supervisor Hall advised that next month he wants the committee members to come up with a recommendation on the heavy pickup being picked up with regular pickup on Tuesdays. This will be placed on the agenda.

The Burned debris left on 25 Maple Avenue is almost gone, debris still remains. It was questioned why this has not been totally cleaned up yet. The Code Enforcement should go through the process for cleanup.

*Reimbursement for CDL license to employees-Supervisor Hall stated this is being offered to the Union in the Contract he advised to just stay with the policy on paying for the CDL.

*Water/Sewer-Public Works (Oakley Sortore)

Road Permit-DOT - Oakley Sortore advised a Resolution is needed.

Supervisor Hall advised that a proper Resolution should be thought out and prepared to be brought forth at the next Regular meeting in November; will be put on the agenda.
